HIV Prevention & Treatment

By enrolling in Illinois HIV Care Connect at no charge, people living with HIV receive help in finding the care and support they need. Once enrolled, a case manager will determine the individual's eligibility for services and benefits from programs including the AIDS Drug Assistance Program (ADAP Medication Assistance), Ryan White Part B, Continuation of Health Insurance of Coverage Program (CHIC Premium Assistance), Housing Opportunities for Persons Living With AIDS (HOPWA), and others. In this way, Illinois HIV Care Connect can help individuals better afford the health care and support services they need to manage HIV and achieve optimal health and self-sufficiency. In many cases, services will be available near an individual's home.

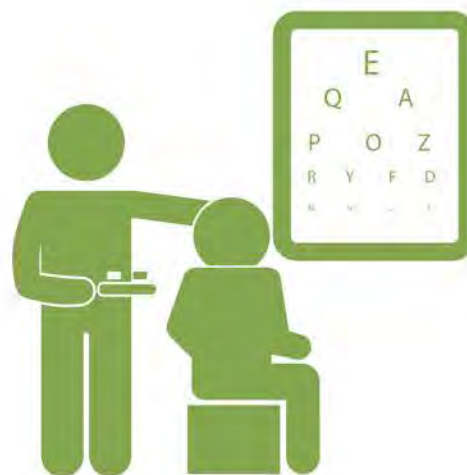
